The facilities can be rented **up to 6 hours** for any one function. Function cannot exceed past 9:00pm. You will be charge extra after 10:00pm. You have (1) hour to clean-up without extra charge. To secure a date \$\frac{\$200 non-refundable}{}\$ deposit must be made. Deposit will apply towards rent. All payments made less then 14 days before function must be paid in cash or certified check.

All charges made during function must be paid in cash. 10% gratuity charge for bar tabs.

A \$500.00 cash Security, Damage/Cleaning deposit must be made prior to function. Upon inspection if no damage, excessive cleaning inside or outside, missing items or no alcohol are found **Deposit returned within 10 days.** All tables and chairs must be clean and put back as found.

**NO ALCOHOLIC BEVERAGES** will be brought onto the premises. Consumption of alcoholic beverage outside of building will not be allowed. **Violation of said rules will terminate function & lost of security deposit.**
